### POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 24 APRIL 2018

At the Annual General Meeting of Great Eagle Holding Limited (the “**Company**”) held on 24 April 2018 (the “**AGM**”), a poll was demanded by the Chairman for voting on all proposed resolutions (the “**Resolutions**”) as set out in the Notice of AGM dated 20 March 2018.

As at the date of the AGM, the number of issued shares of the Company was 690,690,038, which was the total number of shares entitling the shareholders of the Company (“**Shareholder(s)**”) to attend and vote for or against all Resolutions at the AGM. No Shareholders were subject to any restrictions in exercising their votes on any of the Resolutions at the AGM.
