GRANT OF OPTIONS

The Board announces that on 14 March 2017, 5,344,000 Options were granted at an exercise price of HK\$37.15 per Share, subject to acceptance of the grantees, under the Share Option Scheme of the Company. Among the 5,344,000 Options, 1,980,000 Options were granted to the Executive Directors, Substantial Shareholder of the Company and their associates (as defined in the Listing Rules).

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The board of directors (the “Board”) of Great Eagle Holdings Limited (the “Company”) announces that on 14 March 2017 (the “Date of Grant”), 5,344,000 share options (the “Option(s)”) to subscribe for ordinary shares of HK\$0.50 each (the “Share(s)”) of the Company were granted, subject to acceptance of the grantees, under the Company’s Share Option Scheme adopted on 27 May 2009.
